Several second messengers and modulators of intracellular signal transduction pathways are present in the ciliary body (CB) and likely play a regulatory role in the outflow facility of the aqueous humor. Here, we describe the distribution of adenosine triphosphate (ATP), cyclic adenosine monophosphate (cAMP), guanosine triphosphate (GTP), and guanosine diphosphate (GDP), in monkeys, using immunocytochemistry. The subcellular distribution of ATP and GTP was similar, and both were colocalized in smooth muscle cells of the CB and ciliary epithelial cells. GDP was found in the apical ciliary epithelial cells, which is consistent with the reported presence of G protein-coupled receptors in the CB. Moreover, cAMP was colocalized with cholinergic innervation, suggesting a role in the regulation of ciliary muscle tension. The presence of cyclic nucleotides and their modulators is consistent with the reported roles of these second messengers in the CB and provides a mechanism for enhancing ciliary muscle contract

Section 48.11(2) explicitly provides that Federal law, as well as Florida law, applies to actions under the Act. As discussed above, the Act adopts the state limitations period for both substantive claims and repose. Thus, the question before us is whether subsection (2) of section 48.11 provides the exclusive remedy for any action filed under the Act, including the substantive claims of trespass and nuisance. After carefully reviewing the legislative history of the Act, we conclude that the legislature intended to prohibit the state from enacting a statute of repose which impairs or restricts the enforcement of any federal right. Accordingly, any state statute of repose which conflicts with the enforcement of federal law is invalid. 12 The intent of Congress to preclude any state legislation which alters the enforcement of rights under the federal Atomic Energy Act is apparent from the legislative history of the Act. The legislative record reflects that a number of states sought to promulgate statutes of repose prior to enactment of the Act. These state-based statutes were intended to "establish a definite and longer period of time within which a nuclear incident is to be brought to a conclusion... [to] insulate federal employees from fear of continual exposure to liability in the event of a nuclear incident." H.R.Rep. No. 1424, 95th Cong., 2d Sess. 3, reprinted in 1978 U.S.Code Cong. & Admin.News 5840, 5843 (emphasis added). A number of the states, including Florida, had legislation enacted prior to the Atomic Energy Act's passage. 13 Congress passed the Act to remedy the chilling effect that state statutes of repose had on the prosecution of federal employees for a nuclear incident. The legislators had specific knowledge of various state statutes which
